## (57) Abstract:

A system and method for evaluating a corporate strategy in a data network is disclosed. The method includes identifying a set of synergy factors associated to the corporate strategy where the corporate strategy applies to a legal entity. Further, a weight for a synergy factor associated to the legal entity may be evaluated and a score for the corporate strategy may be evaluated based on an estimated weight for each synergy factor. Furthermore, the corporate strategy applicable to the legal entity may be graded based on the evaluated score. Ref. FIG. 1
